Characteristics

- Very good skin tolerance, dermatologically tested with the rating "very good"
- No colourings or perfume oils
- Very pleasant skin care system (innovative emollients)
- Extremely short application times with a wide spectrum of efficacy, based on polyalcohol
- Bactericidal, levurocidal, tuberculocidal and **virucidal** (for high-risk areas)
- With highly-purified ingredients, also licenced as a medical product in Germany

Product type

Skin-friendly disinfectant for application on the hands and on the skin. Within a very short time it provides a comprehensive spectrum of efficacy against bacteria incl. tuberculosis, candida albicans and all viruses such as HIV, HBV, HCV, flu viruses, incl. unenveloped viruses (virucidal!)

Areas of application

Ready-for-use virucidal hand disinfectant with lipid-replenishing effect for the hygienic and surgical disinfection of hands.

Notes on application

For hygienic hand disinfection, rub the hands with 3ml of the solution and keep them moist for the application time stated below. For surgical hand disinfection, rub the hands and forearms with the solution and keep them moist for 1½ minutes. Always close the original container securely after use - dermatologically tested.

Composition

100g of the solution contains:

10g 1-propanol, 55.8g ethanol.

Application times

Hygienic hand disinfection as per EN 1500, VAH:

Conc. 30 sec.

Surgical hand disinfection as per EN 12791, VAH:

Conc. 1.5min.

Bacteria and candida albicans as per EN 13727, EN 13624 (dirty conditions):

Conc. 30 sec.

TbB inactivation (*M. terrae*) as per EN 14348 (dirty conditions):

Conc. 30 sec.

Enveloped viruses (e.g. HBV, HCV and HIV) as per RKI/DVV (high contamination):

Conc. 30 sec.

“Virucidal” (non-enveloped viruses, e.g. polio, noroviruses and adeno viruses) as per RKI/DVV and EN 14476 (dirty conditions):

Conc. 60 sec.

HAV (hepatitis A virus) as per RKI/DVV (dirty conditions):

Conc. 60 sec.
